

BRUNSWICK ART WORKS TILE CONTEST

OFFICIAL RULES

ELIGIBILITY: Contest open to anyone!

ENTRY CRITERIA:

- One entry consists of two drawings; one vertical 4" wide x 8" high and one horizontal 8" wide and 4" high
- Each drawing must be mounted on a separate sheet of white cardstock (or heavy paper) 8.5" x 11"
- Color palette is limited to Black, White, Red, Blue, Yellow and Green
- Must be original work in full color
- Must be able to be recreated and painted on tile by the entrant
- A short explanation of each drawing must be beside the drawing on the front of entry (symbolism, color etc.)
- Each sheet must have its own entry form affixed to the back indicating whether the entry is horizontal or vertical
- All entries become the property of the Brunswick Art Works and will not be acknowledged or returned.

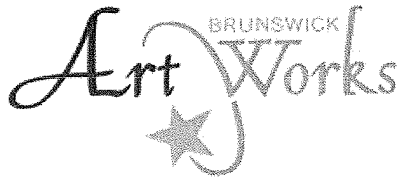
DEADLINE: All entries must be received by 5:00 p.m., Friday, September 10, 2010. Brunswick Art Works is not responsible for delayed mail entries that do not meet the deadline.

HOW TO ENTER: Entries may be submitted by mail or in person, include a check for the fee and the entry form on the back of the entry.

FEE PER TILE ENTRY SET OF ONE VERTICAL & ONE HORIZONTAL: \$10.00 - checks made payable to Brunswick Art Works, Inc.

WHERE TO SEND/DELIVER ENTRIES: Entries may be mailed to Tile Contest, Brunswick Art Works, Inc., P.O. Box 668, Brunswick, Ohio 44212 or dropped off at Brunswick City Hall, 4095 Center Road, Brunswick, Ohio 44212.

WINNERS: 24 horizontal and 36 vertical tiles will be chosen and installed on the park archway which will be constructed by Justice & Company. Winners will be notified by phone. Notifications will be made September 14 & 15, 2010.



WINNERS MUST BE PRESENT ON SATURDAY, SEPTEMBER 18, 2010 FROM 5:00 – 7:00 P.M. AT JUSTICE & COMPANY AT 2462 PEARL ROAD TO PAINT TILES AND MEET ARTIST GREGORY ALIBERTI FROM ALIBERTI ART TILE.

Tiles will be fired **September 20-24, 2010** and installed on the Brunswick Lake Arch **September 25-28, 2010**. A press release will be distributed to local news media of all winners and winners will be listed at www.brunswickartworks.org.

SPONSORS: This contest is jointly sponsored by Brunswick Art Works, Justice & Company and the City of Brunswick. Representatives from the sponsors will judge the contest.

ENTRANT INFORMATION: The entrant must be the design artist and the images must not contain any material that violates the rights of any third party.
